

BARTA Approved Bus Fares

The South Central Transit Authority (SCTA) announced approved changes for BARTA bus fares at its October 21, 2020 Board Meeting.

The approved changes will be effective on Monday, January 4, 2021

SCTA approved to eliminate zones. SCTA also approved to adjust pass prices for better customer savings when customers purchase prepaid passes.

- The cash fare will increase \$0.10 to \$1.80.
- The Adult 10 Ride Pass price will be adjusted to \$13.50.
- The Adult 31 Day Pass will be adjusted to \$45.00.

A Public Hearing was held on Tuesday, October 13, 2020 from 4:00 p.m. to 6:00 p.m. at the BARTA Administrative Offices to receive any comments.
